	16 Nov 2000 (bylaws: Fall Assembly)	LAUC President appoints Nominating Committee
	6 Apr 2001 (at least 65 days before election)	Nominating Committee Chair (Patsy Inouye) submits slate of nominees with their written consent and biographies, to the Secretary.
	13 Apr 2001 (at least 55 days before election)	Secretary submits slate of nominees to each Division in writing, including a notice of the election date and notice that additional nominations may be submitted by members.
	13 Apr 2001 (before May 1)	Divisions appoint Divisional Election Committees. The UCI Nominating-Elections Committee is Yvonne Wilson, chair, Sally Tseng, Bill Wong Committee appointed Nov 30, 2000
	30 Apr 2001 (at least 40 days before the election)	Deadline for additional nominations for LAUC Vice-President/President-Elect and LAUC Secretary. LAUC Secretary receives additional nominations, accompanied by the written consent and biographies of nominees.
	10 Apr 2001	The local Nominating-Elections Committee sends LAUC-I members a form on which to indicate interest for LAUC-I office or standing committee membership.
	27 Apr 2001	LAUC-I office or committee membership interest form due to the Nominating-Elections Committee, who draw up a slate of candidates for each office or committee post, based upon the replies
	14 May 2001 (at least 7 days before election)	LAUC-I Nominating-Elections Committee presents slate of <i>state-wide and</i> local candidates. Additional nominations from the floor for all local offices and standing committees shall be accepted at this meeting
	9 May 2001 (at least 30 days before the election)	Secretary of the Association sends one sample ballot and biographies of nominees to each Divisional Secretary. The ballot shall state the election date, which is the date by which the ballots must be returned to the Divisional election committee chair.
	18 May 2001	Biographical sketch and brief statement of goals from candidates for LAUC-I Vice-Chair/Chair Elect, Secretary/Treasurer, Member-at-Large, and Library Review Committee due to LAUC-I Nominating-Elections Committee Chair
	25 May 2001 (at least 14 days before the election)	Division sends a ballot and biographies of nominees to eligible voters. <i>The chair of the LAUC-I Nominating-Elections Committee sends a ballot and biographies of state-wide and local nominees to each member.</i>
	8 June 2001 (bylaws; during the month of June)	Election Day (date to be determined by the Secretary in consultation with the Executive Board). <i>Deadline for returning ballots to chair of LAUC-I Nominating-Elections Committee.</i>
	13 June 2001	Nominating-Elections Committee counts ballots.
	15 June 2001 (LAUC-I bylaws; not more than 7 days following the election)	The chair of the LAUC-I Nominating-Elections Committee informs the LAUC-I Chair of election results in writing.
	15 June 2001	The LAUC-I Chair notifies the members of the results of the local election.
	19 June 2001 (no more than 10 days after the election)	Secretary of the Association receives election results in writing from the Divisional Secretaries
	1 July 2001 (no more than 20 days after the election)	Secretary of the Association notifies the President, the Vice President, the Divisional Chairs, and all nominees of the results of the <i>state-wide</i> election. Elected officers take office 1 Sept 2000
