The major activities this quarter:

- -Changed the name from Council on Graduate Affairs back to Graduate Council (the old name was best!).
- -This year the Academic Program Review Committee will be doing the reviews for the School of Humanities and School of Social Ecology these reviews are still in progress so Grad Council has not seen any documentation yet.
- -Reviewed various academic program reviews where we have rec'd the documentation-- these are all confidential.
- -Affordable housing for graduate students vis-a-vis the new grad student housing developments is still a big issue for Grad Council and some members are part of an advisory subcommittee to Manuel Gomez. For example, one proposal being debated is putting a time limit on how long people can stay in housing. This would help re recruitment of new grad students, and to ease their transition upon arrival so that they don't have to immediately seek housing--the thinking being that they will have time to scope out other housing options after a year or two and after they are familiar with the environs. Currently there are no time limits and there are extensive waiting lists. The opening of new grad student housing will ease some of this, but not completely. This issue and others still under discussion.
- -Surveyed all schools re "Time to Degree" (time to advancement, time to degree, and maximal time to degree) and there will be further analysis and perhaps direction to schools who are not in alignment w/ policy. Still inprogress.
- -Reviewed various proposals that have been making the rounds of other Senate committees, such as the proposal to revise sexual harassment policy and procedures, etc.

(Spring 2004)

Grad Council Quarterly Report - Issues discussed:

- -Time to Degree GC surveyed schools and depts re: Normal Time to Advancement; Normal Time to Degree; and Maximum Time to Degree. After analyzing the results and surveying other institutions, GC establishedstandards/guidelines for "Time to Degree" for UCI campus schools and depts to follow.
- -Affordable student housing was an ongoing discussion especially in light of Palos Verde II, the desire to provide a greater number of grad students with access to housing, and the present policy which was debated about no time limits on staying in grad student housing.

(Fall 2003)

The Subcommittee on Courses has met three times this year so far. There have been a few new courses approved, a few deletes, and many, many changes in titles, prerequisites, descriptions, and course numbers. These may be the result of an instructor change, or an old mistake, or a domino effect from a change to another course, or of a larger curriculum change.

The Libraries will have already heard about the important curriculum changes, such as the new accounting minor in GSM—they added 11 new accounting courses. Other changes: the dance department has been able to increase the hours for their Advanced Studio Workshops (in Ballet, Modern Dance, and Jazz) because of new facilities, and Bio Sci has restructured some of their lower division offerings, which has affected the prerequisites of many of their courses.

We were told that we will be seeing many requests from the School of Engineering over the next couple months.

I've been sending copies of the course change forms for the new or substantively modified courses to the appropriate bibliographers. The packets of forms for all the changes will soon be in the binder in the approvals room.

(Fall 2003)

The UCI Writing Board is a sub-committee of the Advise the Council on Educational Policy on campuswide policies concerning instruction of writing, on implementation and enforcement of existing policies governing writing requirements, and serve as liaison with Faculties and Academic Affairs on matters concerning the implementation and enforcement of such policies. (full charge to the committee appears at the bottom of this message.) The Board is convened By susan Jarratt, the Campus-wide Writing Director and Professor of English. The Writing Board met twice during the Fall Quarter. We reviewed and provided feedback on the revision of the form used to propose upper-division Writing Courses; reviewed a plan for the review of courses which currently carry a W (fulfills the upper-division writing requirement) designation; approved a letter advising individual faculty and departments of the current standards for teacher to student ratios in upper-division writing classes; heard a report from Susan Jarratt concerning her meetings with the Deans of the schools last spring and; discussed a Committee on Educational Policy recommendation regarding a pilot project to assess upper-division writing in the School of Biological Sciences.

Charge:

The UCI Writing Board is a sub-committee of the Advise the Council on Educational Policy on campuswide policies concerning instruction of writing, on implementation and enforcement of existing policies governing writing requirements, and serve as liaison with Faculties and Academic Affairs on matters concerning the implementation and enforcement of such policies. The Board is empowered to gather information concerning the teaching of writing in courses on campus, students' writing performance, faculty perceptions of student writing problems and achievements, and student perceptions of writing instruction. The Board shall conduct a survey of Faculties on campus to determine the courses in which there are significant writing assignments and the nature of the writing assignments. All writing requirement courses shall be reviewed at the end of three years. The Campus Writing Coordinator shall act as coordinator of all writing courses, and shall serve as liaison with the Faculties, the UCI Writing Board, and the Council on Educational Policy. The Campus Writing Coordinator shall provide the Council on Educational Policy with information concerning the various writing courses offered, whether or not such writing courses meet the breadth requirement, and students' writing performance.

(Fall 2003)

Had a brief meeting on Jan 8, 2004. This has been the only meeting since my last report.

Items discussed:

- 1) Comprehensive Review Manual confidential information on the selection process for undergraduates. Soon, all members of CUARS will go through training to better understand the process of evaluating undergraduate applications.
- 2) Three point proposal for streamlining undergraduate admissions discussed proposal from Office of Pres concerning changes in the admissions process. Many reluctant to give up local control over evaluation of applications, though some see benefit of having a centralized academic performance evaluation system.
- 3) Discussed the need to select a new chair for CUARS.

(Spring 2004)

As of now, the incoming freshman class will be 3,817 students, which is a 7.2% decrease in enrollment. A poor UC budget is to blame mostly for this decrease, since UCI limited the amount of undergrads accepted this year. Higher student fees are also a cause for the drop.

Alternatives put in place to handle the decrease in admitted undergraduates include a dual admissions program -- where undergrads are placed in a community college and then guaranteed admittance to a UC if they maintain a certain grade level. Cal States will also absorb more students too.

Another topic of concern was the notion of "comprehensive review" -- the process by which UCI admissions determines who is eligible for acceptance. Attacks from one UC regent, many of which appeared in the LA Times, spurred our committee to examine the logic behind the review process.
