- 3. Place the sealed unmarked envelope into the addressed larger envelope (9x12) and seal it.
- 4. Sign your name on the line provided in the upper left-hand corner of the large envelope.
- 5. Send the signed envelope to Pauline Manaka, Langson Library Reference Department, LL 144.

Ballots must be returned by 5:00pm on Thursday, June 10, 2004.
