- Standing Charge: (from LAUC-I Bylaws)
 The Academic Librarianship Committee (ALC). The ALC shall address matters relating to the academic status and professional issues of librarians at the direction of or in consultation with the LAUC-I Chair.
- 4. Supplemental Charges/Tasks for 2004-2005 Year:
 - a. Schedule one open meeting date for each quarter of the LAUC-I year and communicate those dates to the Secretary by October 1, 2004.
 - b. Assist Ad Hoc Career Recruitment and Outreach Program Committee (Joan Ariel, Chair), as requested in planning & implementing the second year of the program's strategic plan.
 - c. Review issues raised at Special Meeting of Librarians !2/19/02. In consultation w/the Executive Board, develop a proposal to the AUL for Administrative Services to pursue wide-ranging discussion on any of the outstanding issues that seem beneficial to address.
 - d. We would like to encourage all librarians to send brief reports/summaries on the conferences and meetings or timely issues they hear or see while attending conferences & meeting. You can send them to either LIBITEMS or send an email to the LAUC-I listsery (lauci@lib.uci.edu).
- 5. Key Accomplishments (coordinate with charges above):
 - a. ALC met once during each quarter and the meetings were scheduled on the LAUC-I Master Calendar
 - b. This Ad Hoc Career Recruitment and Outreach Program Committee chaired by Joan Ariel submitted a final report. (See documents under Career Recruitment.) and was disbanded. This committee also published a brochure. ALC has assumed the responsibilities of the Ad Hoc Committee including the updating of the CROP brochure. The listing of librarians and subject areas in the brochure have been revised to reflect the current subject areas of the librarians and will continue to do so.
 - c. The issues raised in the document of 12/19/02 were discussed by the Committee who recommended to the Executive Board and the LAUC-I membership to retire this document and further discussions by the librarians as the issues were outdated or addressed in other venues. In addition, many of the librarians at the original meeting are no longer at UCI. If any of the issues in this document need to be addressed, they can be discussed as part of the IMPAQ workshops and at LAUC-I membership meetings.
 - d. LIBITEMS is no longer being published. The discussion in the ALC Committee and the Executive Board regarding how to promulgate the

librarians' experiences at conferences was not conclusive. Human Resources publishes a list of librarians and the conferences they attend frequently. One of the LAUC-I luncheon meetings set up by the Program Committee was specifically for librarians to share their conference experiences..

6. Recommendations for the Coming Year:

ALC will continue working in the CROP program.

They will also continue to update and revise the CROP brochure.

The Transitional meeting will be held on September 14, 2005 with the previous and new members of the Committee and the new LAUC-I chair. At that time the chair may have new areas for the Committee to pursue.
