Presented by Katie Clark, Associate Dean, Public Services & Collection Development at University of Rochester Libraries and Ann Marshall, Reference Librarian and Political Science Subject Specialist at Rush Rhees Library this program will describe a two-year study of undergraduates conducted at the University of Rochester. The study focused on how students conduct research within the context of campus life. Anthropological methodologies, such as cultural probes, interviews, and mapping diaries, were used to construct a holistic picture of the lives of undergraduates. The results of the study have informed decision making at the Libraries and has helped staff align our efforts with the needs and expectations of the Net Generation

4. Recommendations for the Coming Year:

Continue to give priority to Timely Topics programming over Lunch with LAUC-I meetings. In the past, Lunch with LAUC-I was a monthly event. Planning these monthly meetings, in addition to coordination of Timely Topics programming, is too large a task for the committee.

Also, an opportunity exists to work with Aimee Loya to develop complementary programs with Human Resources. She has been helpful in the creation of evaluations for the committee. In the future, as her office hosts programs, the Program Committee will have an opportunity to assist or provide complimentary/divergent programs for the benefit of the library.

As for lunch with LAUCs, the feedback was very positive for two of the lunches – the LAUC-I book club and the presentations of those who made contributions in the Criterion 4 area (presented, published, etc). I would suggest making the latter lunch event an annual one in the summer to take the place of the "conference reports" LAUC did in the past. Attendees are much more interested in the contributions of the library than a straight report on what was overheard.
