- ♦ Following up on LAUC-I representatives to Senate Committees
 - Sheila Smyth would like to continue as rep for Subcommittee on Courses (SCOC); Carol Hughes would like to continue as rep for Council on Research and Computing and Libraries (CORCL); Lorelei Tanji would like to continue as rep for Graduate Council (GC); and Julia Gelfand would like to continue as rep for Council on Planning and Budget (CPB). One other member has expressed interest in the Council on Planning and Budget (CPB). Board on Undergraduate Scholarships, Honors & Financial Aid (BUSHFA) and Council on Undergraduate Admissions & Relations with Schools (CUARS) are open still.
 - Current LAUC-I Executive Board members can't serve on some faculty senate committees.
 - Brown will hold all positions open for another week or so to give more time for volunteers to come forward.

- New name of committee will be Research and Professional Development Committee (RPDC) as of September 1, 2009.
- LAUC-I RPDC role is to review requests for research grants from the statewide RPDC; help shape proposals from LAUC-I members before they are sent to LAUC RPDC; help new librarians get faculty profiles in place; maintain Librarians@UCI website.
- New role in 09/10 will be to encourage librarians to contribute to the UCI Libraries' instance of eScholarship.
- LAUC-I RPDC will need to elect someone from to be the LAUC PRDC rep; reps meet mid-year to go over current research proposals and submit recommendations. LAUC Vice-President/President-Elect serves as LAUC RPDC chair; LAUC-I RPDC chair is permitted to be the statewide rep.
- ♦ Member-at-Large
 - T. Lin and B. Williams incoming Members-at-Large.
 - Member-at-Large role is to be a divisional representative to LAUC assemblies (North and South); act as liaison between LAUC-I Exec Board and LAUC-I representatives to faculty senate committees (in the past members-at-large have helped committee members when needed [i.e., hunt

7. LAUC Executive Conference Call highlights –

Brown

The conference call didn't happen last week. Other items of interest:

- ♦ LAUC Transition Meeting, August 17 at Berkeley
 - Going forward, structural changes will happen as a result of by-laws revisions put into effect.
 - UCB has a symposium in the fall: they might do some telecommunicating/teleconferencing for those who can't attend; could be a model for other meetings.
- ♦ Letter to EX VP Dan Greenstein on clarification of oversight of LAUC
 - LAUC by-laws state that LAUC works to advise UCOP and the ULs on matters of professional governance. LAUC was being asked to sign paperwork saying LAUC is an affiliate of UCOP, but this isn't the case and needed to be clarified. UCOP apologized and said it was an attempt to identify a unit where money is being spent for the new financial structure of the UC. LAUC is not an affiliate and will remain an advisory arm of UCOP.
- Nominations for LTAG and SOPAG were received and forwarded to ULs for appointment.
- ♦ LAUC Fall Assembly will be at UCB, no date yet.
