4. Timely Topic: Research: A Journey of Discovery May 22, 2009

Initial Invite: The Librarians Association of the University of California, Irvine (LAUC-I) is hosting a workshop on research in librarianship. We are cordially inviting any and all library folk to our campus for this free event.

The speaker will be Jonathan Eldredge, MLS, PhD, AHIP. Dr. Eldredge has published 30 articles in peer reviewed journals in leading library science/informatics journals. His publications cover diverse subjects such as research design, collection development, library education, the public relations and marketing aspects of management, and his favorite current topic: Evidence Based Library and Information Practice (EBLIP).

Jon created the Medical Library Association (MLA) continuing education course on EBLIP in 1998 and has taught this course a total of 22 times both nationally and internationally. Jon's research interests have led him to conduct both quantitative and qualitative research studies, and he has been the principal investigator in four randomized controlled trials.

Jon serves as an Associate Professor for the School of Medicine and the Health Sciences Library and Informatics Center at the University of New Mexico where he has an active research program. At UNM Jon regularly teaches his medical as well as his graduate clinical research,

physician assistant, health policy, and public health students. During both 2007 and 2009 the medical students honored his excellence in teaching by presenting Jon with the "Hippo Award".

5. Lunch with LAUC-I: Qualitative & Quantitative Research Methodology on June 16, 2009 Initial Invite: Our speaker is Mr. David Kennedy. This event will cover research designs that may be helpful for librarians interested in doing research. Specifically, Mr. Kennedy will talk about ways to move beyond just doing surveys and/or focus groups. He will talk about where these two methods fall within the continuum of qualitative and quantitative research designs and he'll talk about other approaches including their strengths and weaknesses. Mr. Kennedy will also point out some useful resources for those wanting to learn more about developing their

own research designs.

David P. Kennedy, Ph.D., anthropologist, is an Associate Behavioral Social Scientist at RAND and a Senior Public Administration Analyst at the UCLA/NPI Health Services Research Center since November 2005. Dr. Kennedy specializes in the combination of qualitative and quantitative research methodology and has investigated a range of subjects, including depression, ADHD, and PTSD. Dr. Kennedy received a Ph.D. in cultural anthropology from the University of Florida in 2002 and was a postdoctoral fellow at the Carolina Population Center for three years studying adolescent romantic relationships and adherence to antiretroviral therapy in South Africa.
