# **ALA Annual Diversity Research Grant Program**

The Diversity Research Grant consists of a one-time \$2000 annual award for original research and a \$500 travel grant to attend and present at ALA Annual Conference. Three grants are awarded each year. Grant recipients will be expected to compile the results of their research into a paper and will be asked to present and publish the final product in conjunction with the American Library Association.

The CARL Research Award was established to provide seed money to encourage CARL members engaged in research and/or publication efforts. A competitive cash award will be awarded to the successful applicants. Individual applicants may apply for awards in the range of \$250 to \$1,500. Groups of two or more recipients may apply for awards in the range of \$250 to \$2,000.

The Carroll Preston Baber Research Grant is given annually to one or more librarians or library educators who will conduct innovative research that could lead to an improvement in services to any specified group(s) of people. The project should aim to answer a question that is of vital importance to the library community and the researchers should plan to provide documentation of the results of their work. The Jury would welcome proposals that involve innovative uses of technology and proposals that involve cooperation between libraries, between libraries and other agencies, or between librarians and persons in other disciplines. Any ALA member may apply.

The Jury would welcome projects that involve both a practicing librarian and a researcher. This grant consists of an amount up to \$3,000.

## **Ingenta Research Award**

The Ingenta Research Award is given annually by the Library Research Round Table of the American Library Association to support research projects about acquisition, use, and preservation of digital information. The grant consists of up to \$6,000 for research and up to \$1,000 for travel to a national or international conference to present the results of the research. Expenditures must directly support research; the award does not cover indirect costs or overhead.

#### **Fulbright Program Opportunities for American Scholars**

The Fulbright U.S. Scholar Program sends approximately 1,100 American scholars and professionals per year to approximately 130 countries, where they lecture and/or conduct research in a wide variety of academic and professional fields.

The Fulbright Specialists Program, a short-term complement to the traditional Fulbright Scholar Program, sends U.S. faculty and professionals to serve as expert consultants on curriculum, faculty development, institutional planning, and related subjects at overseas academic institutions for a period of 2 to 6 weeks.

Proposals must focus on program and research in library and information science for which the applicant is highly qualified and which would result in the advancement of the individuals' professional status and contributions to the community. The applicants must demonstrate interests in research and professional development by presenting papers or reports at conferences, institutes or workshops sponsored by the American Library Association, the Chinese American Librarians Association, the China Society of Library Science and other similar professional organizations.

# Samuel Lazerow Fellowship for Research in Collections and Technical Services in Academic and Research Libraries

SLA supports two types of proposals. Firstly research projects focused on the needs and concerns of information professionals in special libraries and related venues, with its current focus being on evidence-based practice, as in the Special Libraries Association (SLA) Research Statement, "Putting Our Knowledge to Work" (<a href="www.sla.org/researchstatement">www.sla.org/researchstatement</a>). Awards may be granted up to \$25,000. Secondly projects which directly benefit the operations of SLA and its units, by furthering the scientific, literary and educational purpose for which the association is organized and operated. Awards may be granted up to \$10,000.
